

## **MEMORANDUM OF UNDERSTANDING (MoU)**

**Between**

**Bug Detox LLP**

**And**

**Arya College of Engineering, Jaipur**

This Memorandum of Understanding (MoU) is made and entered into on 06-02-2025, by and between:

1. **Bug Detox LLP**, having its corporate office at Kota, Rajasthan, a leading provider of cybersecurity training and workshops, hereinafter referred to as "**Bug Detox LLP**".
2. Arya College of Engineering, located at SP-40, RIICO Industrial Area, Kukas, Delhi Road, Jaipur, Rajasthan, 302028, hereinafter referred to as "**Arya College of Engineering, Jaipur**".

### **1. Purpose**

This MoU is established to foster collaboration between Arya College of Engineering and Bug Detox LLP to enhance cyber security education and training through industry-based programs. The primary objectives include:

- Providing hands-on cyber security training to students.
- Conducting workshops, hackathon, and industry-relevant certification courses.
- Offering internships and career guidance to students.
- Enhancing student employability by equipping them with practical cyber security skills.

### **2. Roles and Responsibilities**

#### **Responsibilities of Bug Detox LLP:**

1. Conduct a three-month offline training program on CEH + VAPT (Certified Ethical Hacking & Vulnerability Assessment and Penetration Testing) followed by a 1.5-month online internship.
2. Provide certifications to students who successfully complete the program.
3. Facilitate biannual workshops, six to eight cybersecurity seminars per year, and exclusive hackathons.
4. Organize two company interaction programs per year for students.
5. Provide access to global learning resources, 24/7 support, and online study materials.
6. Offer career guidance and placement assistance, including campus drives through its platform.

#### **Responsibilities of Arya College of Engineering:**

1. Promote the cyber security program to ensure active student participation.
2. Provide necessary infrastructure and facilities for conducting the offline training sessions.
3. Appoint a Single Point of Contact (SPOC) to coordinate with Bug Detox LLP for program execution.
4. Assist Bug Detox LLP in student enrollment, mobilization, and engagement.
5. Ensure timely communication of program schedules and activities to students.

### 3. Confidentiality and Data Protection

1. Both parties agree to maintain confidentiality regarding any sensitive information exchanged during the collaboration.
2. Student data will be used strictly for enrollment and reporting purposes and shall not be misused or shared without prior consent.
3. Bug Detox LLP cannot utilize student data for commercial purposes without explicit approval from Arya College of Engineering.

### 4. Duration and Termination

1. This MoU is valid for three years from the date of signing.
2. It may be extended upon mutual agreement.
3. Either party may terminate the MoU with a written notice of 30 days in case of non-compliance or breach of obligations.

### 5. Finance


A separate agreement between two parties will be done in case of any paid program.
