3. Item No. BOG/39/03 – To apply for Autonomy at Arya Institute of Engineering & Technology.

Dr. Arvind Agarwal informed that Arya Group is a leading group in the field of education since inception and now it is the right time to go for the Autonomy. Thereafter, he informed attaining autonomy can lead to various advantages for the institution, such as academic and administrative freedom, eligibility for central funding, the ability to design its own courses, and greater decision-making authority.

To attain autonomy, it was suggested that the Institution should apply for recognition under 2(f) of UGC Act 1956. Further it was advised that the necessary preparations should be initiated to begin the process of applying for the same. The decision was appreciated by all members.

4. Item No. BOG/39/04 – Utilization of Budget for the Financial Year 2022-23.

The members were presented with a comparative statement of the actual expenditure versus the approved budget for the Financial Year 2022-23. A comprehensive discussion ensued regarding all the expenditures, wherein each item was carefully examined. After a thorough deliberation, the members unanimously approved the proposed expenditures in the meeting.

5. Item No. BOG/39/05 – To discuss regarding Annual Appraisal.

During the meeting, discussions were held regarding the upcoming Annual Appraisal for the Teaching and Non-Teaching Staff. It was decided that all staff members would need to fill the Self Performance Appraisal Sheet. The IQAC will execute the process as per the policy document, which will be presented before the Board of Governors (BOG) for the final assessment and approval.

6. Item No. BOG/39/06 - To apply for the NAAC 2nd Cycle.

During the meeting, the IQAC Coordinator brought up the matter of the NAAC 2nd Cycle. It was discussed that the institution needs to undergo the accreditation process for the 2nd cycle with NAAC. Further it has been informed that the compilation of departmental data and documents is a significant step in preparing for the NAAC 2nd Cycle assessment. Thereafter to achieve the same all the HODs are directed to compile the necessary departmental data and documents.
