Observations laid down by Board of Inspection

The deficiencies are:-

1. Building safety certificate from the competent authority was not provided.

2. Faculties, designated as professor and Associate professor are not having proper experience as per AICTE.

3. Faculty retention is poor.

4. Some faculties are being paid minimum of PB-3, Rs. 15600/- of AICTE 6th pay scale without any allowances.

5. In the appointments of faculty, HVC nominee was not invited.

6. One of the project laboratories shown during inspection needs modification and asked to develop, exclusively for advance studies for students.

7. In electronics workshop up-gradation is required as per the curriculum.

8. Only 29 laboratory staff were present on the day of visit.

9. 4 system and 24 application softwares were available only.

10. 55 International & 85 National journals are subscribed only. Institute needs to subscribe journals of foreign publications.

11. Quality reference books are to be added in the library.

12. Social, security in term of PF, insurance etc. must be implemented for the staff and faculty members of the institute.

13. Outdoor sports facility needs improvement.

- 14. The proper first-aid facility along with a trained practioner (compounder etc.) is to be provided to the students.
- 15. Faculty cadre ratio is not proper.

Status of the current deficiencies shall be verified by the forthcoming inspection team.

Provisional affiliation may be granted as per decision of BOI for the session 2012-13, presuming that the deficiencies pointed out above are rectified. The compliance shall be verified in the inspection of 2013-14 failing which affiliation for 2013-14 shall not be considered.
